

## **Medication Policy**

Cozy Cattery Boarding Resort & Grooming Spaw Staff are happy to administer any veterinarian prescribed medications your Pet requires. Please make sure to tell our staff when making a reservation & at check-in that your Pet will need medication. **As required by the USDA**, medications must be brought in their original container from the vet or pharmacy and be clearly labeled with your Pet's name, veterinarian contact info, and dosage. Pet parents will provide the necessary items to administer medications such as oral pillers, pill pockets, needles, droppers etc.

For those pets who will not easily take their medications, we use various methods/food items to entice them. However, we will not jeopardize the safety of our staff to force a pet to take their medication and/or cooperate with giving eye/ear drops/injections. If your pet's health is dependent upon receiving medications, and they are shy/skittish or aggressive, we suggest boarding them in a veterinary office where you can be assured they receive the necessary medical attention.

- Pills and ear/eye drops/ointment for cooperative cats are administered at a \$5.00 per pill charge.
- Insulin shots for cooperative cats are administered at a \$5.00 per injection charge.
- Sub-Q fluids for cooperative cats are administered at a \$10.00 per injection charge.

We will administer meds only between 6 a.m. -8 a.m. and 4 p.m. -5 p.m. daily. If your pet must have their medications outside of these time frames, you may want to seek alternative boarding options. If you have any questions about your pet being given meds only during these hours, we recommend talking to your vet office for their input.

All medication must be provided at check-in, and administration procedure must be documented in writing prior to your departure. Please bring a list of all medications and dosage information. Please allow sufficient time to accomplish this accurately. Additionally, we request that you bring with you sufficient medication for at least two additional days' stay. In the event your return is delayed, your pet will still be safe and healthy when you return.

We enjoy having your pet stay with us and are happy to administer medications. However, we want you to be aware of limitations and conflicts that can occur when boarding and your pet may not take their medication the same way that they do at home. Any additional questions regarding medical issues can be discussed with our office staff (preferably before dropping off for stay).
